### **BACKGROUND**

ADAMH is a local, levy-funded agency that plans, funds, and evaluates behavioral healthcare services in our community. ADAMH does not provide any direct alcohol, drug, or mental healthcare services, but instead contracts with more than 30 non-profit organizations. ADAMH, representative organizations from the ADAMH network, Franklin County Board of Commissioners, Central Ohio Hospital Council, Mount Carmel, OhioHealth, OSU Wexner Medical Center, Columbus Fire and Police, The Columbus Foundation, Osteopathic Heritage Foundation, consumer and family advocacy organizations, and other community stakeholders have formed a Steering Committee to facilitate the development of a comprehensive center intended to support the wellness of adults in Franklin County experiencing (or at risk of experiencing) a crisis associated with their mental health and/or substance use disorder.

The Franklin County Mental Health and Addiction Crisis Center is intended to support adults in Franklin County experiencing (or at risk of experiencing) a crisis associated with mental health or substance use disorder. The center will be a central core facility in Franklin County and will serve as a preferred destination for mental health and addiction crisis needs. The crisis center will decompress hospital emergency departments and observation beds and will have the capability to facilitate medical clearance and patient transfers.

#### CRISIS CENTER GOALS AND OBJECTIVES

The objectives of the Crisis Center are to:

• Increase access to mental health and addiction crisis care, so that it meets the needs of Franklin County, including at-risk and socially disadvantaged populations. The Crisis Center will provide access 24/7 to self-referrals, EMS,

- police and hospitals, and will serve other community stakeholders including the probate court and community-based providers.
- Improve quality of crisis care, by offering a spectrum of mental health and addiction services (from lobby-level to observation to inpatient) and direct links to communitybased programs after crisis care is provided.
- Construct a facility that meets current and future demand. Franklin County is forecasted to have a 23% growth in outpatient mental health and addiction services in the next 10 years.
- Provide a central core facility that serves as a preferred destination for mental health and addiction crisis needs, while simultaneously decompressing hospital EDs, and reducing the need for medical clearance.

Access: 24 hours/7days a week, including a public walk-in entrance and an entrance for EMS and law enforcement.
