Dear Interested Participant:

The Ohio Department of Mental Health and Addiction Services (OhioMHAS) is making new state opioid response (SOR) funding available this summer. SOR 3.0 focuses on building an integrated behavioral health system continuum of care for individuals with a primary diagnosis of opiate use disorder or stimulant use disorder. OhioMHAS' priorities for the SOR funding include expanding access to prevention; medication-assisted treatment (MAT); harm reduction; and recovery supports.

In preparation for this funding, the ADAMH Board of Franklin County is seeking proposals for services related to opiate and stimulant use disorder including but not limited to psychosocial services, youth services, vocational training, and workforce development. The programs should bridge the gaps of need within our community by connecting a variety of existing and new community level partners from faith-based organizations, minority community organizations, supported and recovery housing organizations, and others.

ADAMH is requesting the following information about your organization and your proposed service to include a project description; goals and objectives; staffing/subject matter expertise; data collection plan; technology/telehealth; disparities impact statement; sustainability plan; logic model; and budget and budget narrative. In addition, we request that your proposals include a reference to your anticipated Government Performance and Results Act assessment (GPRA) return rate. GPRA assessments must be completed at intake, every six months ongoing thereafter, and at discharge. SAMHSA requires a GPRA return rate of at least 80%. Proposals should also reflect a connection to the social determinants of health and the components of a recovery-oriented system of care.


ADAMH will submit a comprehensive proposal to OhioMHAS based on the programs submitted in response to this RFP. Organizations must submit one proposal for each project they would like funded. If you propose more than one program, you must submit multiple applications including independent budgets to be evaluated separately. First time applicants are limited to a maximum of \$200,000 annually.
