KY24 ASP/Budget FAQs



1. Are the ADAMH Medicaid reimbursement rates the same as Medicaid for 2024?

Ohio Department of Medicaid (ODM) reimbursement rates for 2024 have not been released. All ADAMH reimbursement rates for Medicaid covered services will increase 5% in 2024. ADAMH will consider other adjustments in 2025 to come into alignment with new ODM reimbursement rates.

2. How do providers get additional funds for program expansion or adding new programs?

Requests for additional funds are not being considered during the KY2024 ASP/Budget process. Information about separate KY2024 funding requests will be forthcoming.

3. Why is ADAMH returning to the 90% threshold?

The threshold reduction was intended to be temporary due to system transitions and the impact of the COVID pandemic.

4. Since there is no Block Grant Funding Request (BGFR)in December, can providers draw remaining funds, not just 1/12, on the November BGFR?

Yes, all providers will have access to their full levy allocations on the November BGFR as a result of the start of year 10% advance of levy allocations.

5. Should we duplicate ASP Narrative Forms to provide one per program?

Use only the ASP Narrative Forms provided that are aligned to the system of care categories. One form can be used to describe multiple programs if multiple programs are supported by the corresponding allocation(s).

6. Why were some allocations reduced?

ADAMH reduced some allocations that have been under-utilized to re-allocate those funds across the system.

7. Do providers still need to project the number of units for the prevention allocation since it is moving to an exempt block grant?

Yes, for all allocations that have a claiming expectation (i.e., encounter claim requirements of "exempt 90%T" or "required"), on the SOC Services Detail sheet provide the projected unit volume for services planned to be utilized in 2024. Excluding allocations fully exempt from claiming, most prevention allocations were changed to "exempt 90%T" so that while these allocations are

- not required to meet the contractual 90% claiming threshold, claiming is still required.
